- 2 Supplemental Funding Opportunities: The Executive Director presented two new funding opportunities. Commissioner Bartolome inquired about the breakdown of the funds from OTS, noting that 21% is direct services. The ED explained that funding covers car seat cost, car seat checks, and one on one appointments. What it does not show is the in-kind time of all the Certified Passenger Safety technicians in the First 5 Office Supporting education and installation for all families. OTS only shows the physical portions of the car seats.

 - Sutter yuba Behavioral Health Cal Mental Health Services Act Mini Grant for the Community Group – Momigas - \$7,000
