3. Sponsorships for the end of the FY20/21
  - a. Gold Sox - First 5 Thursdays ended in early August years of age.
  - b. Peach Festival - provided a children's area
4. Supply Distribution 8/25/21 to local childcare providers and preschools
5. First 5 California Family Book Distribution Partnership – will provide additional funds to build our Imagination Library enrollment up to 65% of eligible population (approx. 4,000 children) for the next two years.
6. Packard Foundation Grant – Family Friend Neighbor Digital assistance. Able to use remaining funds to collaborate with YCOE Child Development Behavior Specialist for a video series “Games for Growth” to show parents how to use the games to help build specific social-emotional skills.
