

## 23-24 Mini-Grant Frequently Asked Questions

**Q:** What is the deadline to apply?

**A:** *Friday, September 22, 2023, at 5:00 p.m. No applications will be accepted after this deadline. (page 7 of the [program guidelines](#)).*

**Q:** How much can I request?

**A:** *Applicants may request up to \$3,000.00. However, requesting less than the maximum amount is encouraged. That will allow the available funds to serve more Yuba County children and families. (see page 3 of the [program guidelines](#)).*

**Q:** Is this just for Yuba County?

**A:** *Services must be provided in Yuba County to serve Yuba County families. If the applicant is physically located outside of Yuba County they must demonstrate they have a way to use the funds only for Yuba County families. (see page 3 of the [program guidelines](#) under eligibility).*

**Q:** Will we be able to get a copy of the presentation for reference?

**A:** *Yes, if you would like a copy of the slide deck of the presentation, please email Robin [rtimoszyk@co.yuba.ca.us](mailto:rtimoszyk@co.yuba.ca.us).*

**Q:** I missed the live webinar. Is there another orientation?

**Q:** Can others apply if they did not attend the September 1, 2023, webinar?

**A:** *Yes, they will be able to ask for the recording link to be emailed to them by emailing Robin at [rtimoszyk@co.yuba.ca.us](mailto:rtimoszyk@co.yuba.ca.us).*

**Q:** What can grants be spent on?

**A:** *The grant money can be spent on items to support your project. In the past, grantees have used the funds for books, equipment, conference expenses, staff time, etc. (see page 5 of the [program guidelines](#)).*

**Q:** Is there a specific form for the budget (Exhibit B)?

**A:** *No, it can be a simple table or bulleted list. Use the format that is easiest for you as an applicant.*

**FAQ continued**

**Q:** If an applicant received a Mini-Grant in 2022-2023 does it fall under the question, “Are you currently receiving funds...” on the application?

**A:** *No, the phrase “currently receiving funds” refers to our fiscal year which starts on July 1. If you received a Mini-Grant before July 1, 2023, you are not currently receiving funds.*
